## **Summary**

This first annual report on the National Statistical System (NSS) produced by the National Institute of Statistics (NIS) is required by the Sub-Decree on Designated Official Statistics, approved by the Royal Government of Cambodia (RGC) in 2010. It gives an overall view of the system for designated official statistics in Cambodia and activities carried out in 2010 by NIS and statistical producers within the NSS.

In 2010 the National Statistical System consisted of, besides NIS, 27 line ministries, government institutions and National Bank of Cambodia. All of these are responsible for designated official statistics in Cambodia defined in the Sub Decree on Designated Official Statistics. NIS is responsible for the coordination of the system. The statistical production is decentralized.

The disadvantages but also the advantages with a decentralized National Statistical System require a coordination of the work conducted in the different entities in the system.

Following the developing statistical legislations<sup>1</sup> and implementation of it NIS started to reorganize by adding three more departments including the Department of Statistical Standards and Analysis being responsible for the coordination activities at NIS.

Statistics Law governs all matters relating statistical data and pertains to the whole Kingdom of Cambodia. Under the Law there are two Sub Decrees that define the work for the NSS. NIS also has a Sub-Decree on the organization of NIS which is not described in this report. The Statistics Law regulates that the NIS, under the Ministry of Planning, shall be responsible for making official statistical policies in establishing an integrated NSS, encompassing all designated official statistics and statistical organizational units within ministries and institutions.

The Statistics Law also regulates that a Statistics Advisory Council (SAC) chaired by Minister of Planning shall be established to provide advice to the Ministry of Planning in facilitating the development of the National Statistical System. Also a Statistics Coordination Committee (SCC), chaired by Director General at NIS shall be established to assist the National Institute of Statistics of the Ministry of Planning in the technical coordination of the official statistics of the Royal Government.

The Sub Decree on Organization and Functioning of the NSS governs all organizational matters and the functioning of the national statistical system, statistics obligations and all relevant matters in order to implement the Statistics Law of the Kingdom of Cambodia.

The NIS is the official statistical policy-making body of the Royal Government, with the responsibility for establishing and leading an integrated NSS which covers all designated official statistics of ministries, government institution and the statistics units of provinces, municipalities, districts, khans and statistics staff in communes and sangkats.

The Sub Decree on Designated Official Statistics aims to designate ministries and institutions of the Royal Government to collect and compile the designated official statistics by its own sector. The Sub Decree defines which surveys the statistical units shall be responsible for. Altogether 27 line ministries and government institutions including the National Bank of Cambodia are responsible for the Designated Official Statistics other than the statistics produced by NIS.

The Sub Decree stipulates that all existing data collection shall be registered within the NIS. Planned and new data collection shall also be registered before commencement of work. A list of all existing data collections, cost and status of each data collection shall be submitted to the Council of Ministers the first year after the Sub Decree was approved. The list needs to be updated each year.

The designated statistical units within ministries and government Institution shall submit all information and statistical data produced in electronic and paper form to the National Institute of Statistics and the Council of Ministers regularly and timely.

All in all more than 600 staff within different line ministries, NIS and National Bank of Cambodia worked in 2010 with designated official statistics. Nearly 52 percent of them worked at NIS.

In the second semester of 2010 a competence inventory within NSS was conducted showing that approximately half of the staff working with designated official statistics has an academic degree and showing that only one third of the staff have enough skills to carry out the tasks in a statistical unit. There is among others lack of ICT skills and English language skills but also basic statistical knowledge is lacking.

In 2010 forty different kinds of reports, though with different frequency, were published according to the NSS inventory. Most of the reports were annual reports but also quarterly or even monthly reports were published.

Data collected by the NSS has not fully been published though designated official statistics need to be published to <u>all</u> users. This has to improve during 2011.

#### THE CAMBODIAN NATIONAL STATISTICAL SYSTEM

## 1 Background

The National Statistical System (NSS) is, defined in the Statistics Law (art. 2), "integrated statistics data at national and local level and infrastructure, including all official statistical data and national statistical programs; statistical organizations and statistical units within ministries and institutions of the Royal Government; as well as their statistical staff and other infrastructure".

An Annual Report on the National Statistical System (NSS) is required by the Sub-Decree on Designated Official Statistics, approved by the Royal Government of Cambodia (RGC) in 2010. This Annual Report is the first report to be produced by the National Institute of Statistics (NIS) and will give an overall view of the system for designated official statistics in Cambodia and activities carried out in 2010 by NIS and statistical producers within the NSS.

In 2010 the National Statistical System consisted of, besides NIS, 27 line ministries, government institutions and National Bank of Cambodia. All of these ministries and institutions are responsible for designated official statistics in Cambodia defined in the Sub Decree on Designated Official Statistics. NIS is responsible for the coordination of the system. The statistical production is decentralized. Characteristics of a decentralized system are the following:

- Surveys to be done and variables to be used are decided in different organisations
- Classification systems, methods and standards might differ within the system
- Terms and concepts are decided in different organisations
- The principle of presentations are different in different organisations
- The statistics are published on different websites

There are many advantages of a decentralized NSS, e.g. the designated statistical units can specialize in a particular area of statistics and work closely with the main data users in the same Ministry. Sometimes it can be easier to find financing for the statistics than if all statistics were produced by one large National Statistical Institute. There are, however, some disadvantages of a decentralized NSS. Statistics and methods can develop independently and tend to create different methods, definitions and standards. This causes problems for the users of the statistics who want to compare statistics over time and over space e.g. the user wants to compare data on households from different surveys. It should also be possible of making joint use from different sources for other purposes than comparisons. At the same time it can perhaps be hard for a user to find statistics if there are many producers and no central portal for all designated official statistics. The risk for duplication is also higher. Therefore there is a need to coordinate the work between the statistical units within the NSS and NIS is the responsible body for coordination. The Statistics Law was enacted in May 2005 and the Law defines and

regulates the designated official statistics. Now the work has started to coordinate the statistical work in order to comply with the legislation. This report will present the work carried out and the statistics produced within the National Statistical System.

## 1.1 Legislation decisions and implementation

The Statistics Law in Cambodia was enacted in May 2005 and related sub-decree on the organization and functioning of the national statistical system (NSS) was fully in effect in January 2007. By then; the Statistics Advisory Council (SAC) and the Statistics Coordination Committee (SCC) were established. A Statistical Master Plan (SMP) 2008-2015 was developed and approved by SAC in April 2007 that supports the NSS in the development of important and urgent statistics for policy making and for basis to the government work on poverty reduction.

In 2009, NIS was reorganized by adding three more departments including Department of Information and Communication Technology (ICT), Department of National Accounts and Department of Statistical Standards and Analysis. During that time CAMInfo was expanded as one bureau of department of Statistical Policies and Cooperation. The Department of Statistical Standards and Analysis is responsible for the coordination activities at NIS whereas the Department for Statistical Policies and Cooperation is responsible for legislative matters for the system, international cooperation and also to prepare and conduct SAC and SCC meetings.

Besides the Statistics Law from 2005 and Sub-Decrees regulating NIS solely, the legal frameworks of NSS are:

- Sub-Decree on the Organization and Function of the National Statistical System approved in 2007
- Sub-Decree on Designated Official Statistics, approved in 2010.

## 1.2 Recent capacity development of NIS

NIS, through the support of Sida, is presently strengthening its capacity in coordination work to assist the designated statistical units in the implementation of the legislation of the National Statistical System. Sida gives technical assistance e.g. on the job training in coordination work and training in Statistics. There are some activities that NIS needs to carry out in 2010 and 2011 to comply with legislation that the Sida project is assisting in i.e. setting up a directory for designated official statistics and a working process to collect information for the annual reporting to the Council of Ministers.

The main task for NIS in the Sida project is still, however, to carry out the Cambodia Socio Economic Survey (CSES) and analyze and disseminate the results. Also capacity building in ICT, statistical methodology and Human Resource Development (HRD) are carried out, which the coordination work will benefit from. By the support from the Sida project, NSS is integrated more in the region and the world. NIS has attended regional and international workshops, meetings, trainings and study tours the past years, with the support from the Sida project. These activities will continue in 2011.

Another important capacity development activity for NIS, with support from JICA, is to carry out an Economic Census. An establishment listing was carried out in 2009 and a large pilot survey on Economic Census was carried out in 2010 as a preparation for the Economic Census in 2011. JICA will also improve institutional capacity development at local offices by providing computers, equipments and infrastructure, on-the-job training in analyzing and disseminating sub-national data such as population census, economic census and surveys and review training needs of statistical staff at each provincial/municipality office. Between 2005 and 2007 JICA had statistical training for NIS, provinces and line ministries. There were courses in Introduction to Official Statistics, Statistical Survey Design, Statistical Data processing, Statistical Analysis, Dissemination and Use of Statistics, Use of local area statistics and Use of Statistical Survey results. In addition, many on the job trainings were provided.

NIS is participating in regional projects like United Nations Statistics Division pilot project on improving the collation, availability and dissemination of MDG data and UN-ESCAP pilot project on the improvement of disability measurement and statistics in Asia and Pacific region.

UNFPA in Cambodia has been supporting population activities of the NIS from 1995 onwards. The first Demographic Survey in 1996 and the first population census in Cambodia in 36 Years in 1998 were conducted with UNFPA support. The inter-censal Population Survey in 2004 (ICPS 2004) was also assisted by UNFPA. In 2006 the RGC made a decision to conduct the 2008 Population Census. UNFPA, JICA, Government of Japan and Government of Germany provided technical and financial assistance for the various activities concerned. The Cambodia Demographic and Health Survey (CDHS) were carried out in 2000 and 2005 and in 2010 the survey was carried out with the assistance by USAID, UNFPA, UNICEF and some other donors.

UNICEF is assisting NIS with CAMInfo, a socio-economic database system that provides a common platform for government, development partners, NGOs and civil society to organize and present data on development indicators. Indicators presented in the database are related to Cambodia Millennium Development Goals (CMDGs), National Strategic Development Plan (NSDP), Education, Health, Cambodia Nutrition Investment Plan and Others. The database can be found on NIS website.

## 1.3 Coordination by broad cooperation is the guiding star

In many ways, coordination is a necessary condition for developing a sustainable NSS and producing quality official statistics. Cambodia has chosen to coordinate by broad cooperation with all designated statistical units to reach a sustainable statistical system and have quality official statistics. The coordination with all designated statistical units will reduce the costs for designated official statistics in the long run and raise the issues of quality and availability. If statistics are used and appreciated by the users, they will most likely be more eager to support the statistical production.

Based on the legislation, the details are set up by NIS in cooperation with designated statistical units where each key player plays different roles in the broader cooperation. Overall, there is a lot of work for a designated statistical unit as well as for NIS as

leading key player of the coordination work. Coordination and cooperation between designated statistical units and NIS is a guiding star of ensuring the provision of quality statistics for the development of Cambodia.

#### 2 Law and Sub Decrees

Statistics Law governs all matters relating to collection, processing, compilation, analysis, publication and dissemination of statistical data and pertains to the whole Kingdom of Cambodia. Under the Law there are two Sub Decrees that define the work for the NSS. NIS also has a Sub-Decree on the organization of NIS which is not described in this report.

The technical terms used in the legislation are presented in article 2 in the Statistics Law and in the Sub Decree on the Organization and Functioning of the National Statistical System. Some of the terms are presented in both documents.

#### 2.1 Statistics Law

Besides defining the framework for which matters the Statistics Law governs, the Law also describes technical terms, principles and directions for the producers of designated official statistics. Censuses to be carried out are also presented.

Regarding coordination and cooperation the Statistics Law regulates that the NIS, under the Ministry of Planning, shall be responsible for making official statistical policies in establishing an integrated NSS, encompassing all designated official statistics and statistical organizational units within ministries and institutions. The Royal Government shall issue a Sub-Decree on the operation of the NSS and designated official statistics.

The Statistics Law regulates that a Statistics Advisory Council (SAC) shall be established to provide advice to the Ministry of Planning in facilitating the development of the National Statistical System (art. 15) and a Statistics Coordination Committee (SCC) shall be established to assist the National Institute of Statistics of the Ministry of Planning in the technical coordination of the official statistics of the Royal Government (art. 16). The composition, role and tasks of the Statistics Coordination Committee are determined by a Sub-Decree.

The statistical data produced by NIS and statistical units shall be published and disseminated to <u>all users</u> (art. 19) and all statistical data released by NIS are designated official statistics (art. 20)

The confidentiality of the data is regulated in article 22 where it says that NIS and the statistical units shall ensure confidentiality of all individual information obtained from respondents, except under special circumstances with the endorsement of DG, NIS and the consent of the Minister of Planning. Micro data can be released if the user ensures the confidentiality of the data and if the data is to be used for statistical purposes only.

#### 2.2 Sub Decree on Organization and Functioning of the NSS

The Sub Decree on Organization and Functioning of the NSS governs all organizational matters and the functioning of the national statistical system, statistics obligations and all relevant matters in order to implement the Statistics Law of the Kingdom of Cambodia.

The NIS is the official statistical policy-making body of the Royal Government, with the responsibility for establishing and leading an integrated NSS which covers all designated official statistics of ministries, government institution and the statistics units of provinces, municipalities, districts, khans and statistics staff in communes and sangkats.

The organizational structure of the national statistical system consists of the NIS, other designated statistical units and the staff employed in those units.

The Function of the SAC is to advise the Minister of Planning, in relation to Determining official statistical policies and requirements to be addressed by the NIS and designated Statistics units.

The establishment and directions of the SAC is regulated in the Sub Decree, e.g. the composition and the regularity of the SAC meetings. The SCC is regulated in the same manner by the Sub Decree. The members of the SAC and the members of SCC shall attend the meeting by invitation of the Chairperson.

The Function of the SCC is to assist the NIS, in relation to preparation of statistical policies, procedures, and legislation for the national statistical system and official statistics. The SCC may establish technical working groups to address specific statistical technical matters that may require more detailed study and discussion.

The Sub Decree also stipulates the confidentiality of results. No results or abstracts shall be published or disseminated in a manner that enables the identification of a particular person or organization.

The tasks defined in the Sub Decree for NIS and the producers of designated official statistics are described in section 3.5 and 3.6.

#### 2.3 Sub Decree on Designated Official Statistics

The Sub Decree on Designated Official Statistics aims to designate ministries and institutions of the Royal Government to collect and compile the designated official statistics by its own sector (art. 1) and governs all designated official statistics and designated official statistical units as specified in the Statistics Law.

The Sub Decree aims to serve the statistical information requirement of policy-makers in formulation and evaluating policies and socio-economic programs in responding to the socio-economic development of the country, as well as the information needs of decision-makers and researchers in the wider national and international communities.

All statistical data released by the National Institute of Statistics are designated official statistics. The National Institute of Statistics shall disseminate to the public with the basic statistics and sector statistics, either produced by itself or in cooperation with other statistical units of the Royal Government such as:

- Census statistics
- Survey Statistics
- Economic Statistics

- Environment and National Resources Statistics
- Socio-Demographic Statistics
- Compendium Statistics

The Sub Decree defines which surveys the statistical units shall be responsible for. Altogether 27 line ministries and government institutions including the National Bank of Cambodia are responsible for the Designated Official Statistics other than the statistics produced by NIS.

In chapter four of the Sub Decree the data management and source data collection is regulated. Article 8 stipulates that all existing data collection shall be registered within the NIS. Planned and new data collection shall also be registered before commencement of work.

A list of all existing data collections, cost and status of each data collection shall be submitted to the Council of Ministers the first year after the Sub Decree was approved. The list needs to be updated each year (art. 10).

The Designated Statistics units within Ministries and government Institution shall submit all information and statistical data produced in electronic and paper form to the National Institute of Statistics and the Council of Ministers regularly and timely (art. 11).

The National Institute of Statistics shall establish and maintain a directory of administrative and statistical data sources, based on the metadata information collected through the registration process. The metadata directory shall be updated on an annual basis and released via website of the National Institute of Statistics (art. 12).

## 3 The structure of the National Statistical System

## 3.1 Definition of Designated Official Statistics

Definition of Designated Official Statistics according to item 10, article 2 in the Statistics Law is "Designated official statistics are statistics produced by Government organizations that are determined by the Royal Government to meet the statistical information requirement of Policy makers as well as the requirements of decision makers and researchers".

#### 3.2 General description of the National Statistical System

The NSS in Cambodia is highly decentralised. The central institution in the NSS is the NIS at Ministry of Planning. According to the Statistics Law, the NIS is the official national statistical institution of the Royal Government, with the responsibility for establishing and leading an integrated national statistical system which covers all designated official statistics and statistical units within ministries and government institutions. In addition to the NIS, each ministry and other government institution have a statistics unit responsible for producing statistics. Various ministries and other institutions collect and produce statistics as part of their work. The system consists of NIS and 27 line ministries, government institutions and National Bank of Cambodia, all members of Statistics Coordination Committee and producers or users of designated official statistics.

Under the Law the NIS has the authority to establish:

- 1) coordination and cooperation in activities of statistical development, including training, with the ministries and government institutions, as well as the private sector at the national and sub-national level;
- cooperative arrangements in statistical activities with international organizations, other national statistical offices and other private institutions; and
- 3) national statistical standards pertaining to classifications, concepts, definitions and statistical units.

The NIS is also mandated to take charge in the maintenance, updating and implementation of statistical program for the government and supply data for other users in the country as well as international organizations.

According to the Sub-Decree on the Organization and Functioning of the National Statistical System, the Statistics Advisory Council and the Statistics Coordination Committee were established in January 2007 to assist NIS in technical coordination of the official statistics.

## 3.3 Tasks and composition of the Statistics Advisory Council (SAC)

The establishment of the SAC is stipulated in the Statistics Law. The SAC consists of the Minister of Planning (Chairperson); the Secretary of State, MoP in Charge of Official Statistics (Vice Chairperson) and a representative Secretary of State from each of the main economic and social policy Ministries and government institutions: Council of Ministers; Ministry of Interior; Ministry of Rural Development; Ministry of Economy and Finance; Ministry of Commerce; Ministry of Education, Youth and Sports; Ministry of Agriculture, Forestry and Fisheries; Ministry of Industry, Mines and Energy; Ministry of Social Affairs, Veterans and Youth Rehabilitation; Ministry of Post and Telecommunication; Ministry of Health; Ministry of Public Works and Transport; Ministry of Tourism; Ministry of Women's Affairs; National Bank of Cambodia (Deputy Governor); and one representative of academia. The Director General of the NIS acts as Permanent Member. A total of 19 members present the SAC.

The tasks of the SAC are to advise the Minister of Planning, in relation to:

- Determining official statistical policies.
- Identifying statistical priorities and requirements to be addressed by the National Institute of Statistics and designated statistical units.
- Improvement, extension and coordination of the national statistical system and designated official statistics provided for public purposes.
- Updating the Statistics Law, Sub-Decrees, and other regulations in relation to statistical matters.
- Annual, medium, and long term statistical priorities and work programs of the National Institute of Statistics and designated statistical units involved in producing official statistics.
- Statistical master plan.
- Determining the dates of conducting the population, agriculture, and establishment censuses.
- Any other matters relating generally to the national statistical system and official statistics.
- Seeking assistance and support, financial and human resources required by the National Institute of Statistics and designated statistics units, in order to conduct censuses and surveys, and to produce and disseminate official statistics for public purposes.

The SAC held its first meeting on 30<sup>th</sup> April 2007. The meeting discussed on the preparation of the Statistical Master Plan (SMP) for Cambodia including to identify long term priority planning of statistical work, develop framework and financing resources for running the statistical system to be efficiency implementation. This SMP had to pass from statistical council members first before submitted to Council of Ministers for approval. At the SAC meeting the draft Statistical Master Plan was approved.

# 3.4 Tasks and composition of the Statistics Coordination Committee (SCC)

The establishment of the SCC is specified in the Statistics Law. The SCC consists of the Director General, NIS (Chairperson); the Deputy Director General, NIS (Vice Chairperson); Director of Policies and Statistical Cooperation Department, NIS (Secretary); and the heads of each statistical unit within each of all ministries and government institutions as member, altogether 32 members.

The tasks of the SCC are to assist the NIS, in relation to:

- Preparation of statistical policies, procedures, and legislation in relation to the national statistical system and official statistics.
- Establishment of an integrated national statistical system through effective coordination and cooperation on statistical activities and statistical development between designated statistical units, including the National Institute of Statistics, responsible for producing and disseminating official statistics.
- Improvement and extension of the national statistical system and official statistics provided for public purposes.
- Development of annual, medium and long term priorities and programs of work that should be adopted in relation to major aspects of the provision of those official statistics by the National Institute of Statistics and designated statistics units.
- Preparation and updating of statistics master plan.
- Planning the conduct of population, agriculture, and establishment censuses.
- Establishment and annual updating of a register of businesses or population frame, and a directory of administrative and statistical data sources in relation to the national statistical system.
- Implementation of cooperative agreements between ministries, institutions, and other government units on data sharing and the timely provision of accurate and reliable official statistics.
- Establishment of fixed-term or permanent technical working groups for specific statistics or other statistical matters in relation to the national statistical system and official statistics.
- Promulgation and implementation of statistical classifications and standards in relation to official statistics.
- Development of financial budgets and human resource plans for designated statistics units, including the National Institute of Statistics, in order to conduct censuses and surveys, and to produce and disseminate official statistics provided for public purposes.

## 3.4.1 Committee meetings

So far, seven SCC meetings have been conducted. Since this is the first Annual Report all the meetings will be mentioned. As from next year's edition, only the past year's Committee meetings will be described.

The first SCC meeting was held on 15 February 2007. It discussed the preparation of the Statistical Master Plan (SMP). There was an updated version of the SMP produced in August 2006, which updates dates and costs. The SMP was to be submitted to the SAC for approval. This was an important process in advocating for government support and resources to ensure that the statistical coordination work is effective. The SMP tried to ensure that there was enough money for quality statistics produced by NIS and line ministry statistical units.

At the second SCC meeting on 27<sup>th</sup> July 2007, it was discussed on the preparation of the draft of the Sub Decree on the Designated Official Statistics which required the line ministries to compile and send information to the inventory of the statistics that they produce regularly. At that time, the meeting requested the comments from line ministries on the proposed list of Designated Official Statistics.

The third SCC meeting was held on 18<sup>th</sup> December 2008. This SCC meeting was delayed due to some events such as the general election, conduct of the General Population Census of Cambodia, then the SCC met only once during 2008. The meeting continued to examine the draft of the Sub Decree on the Designated Official Statistics by asking from line ministries to add some important statistics and/or remove those that were unnecessary.

On 22<sup>nd</sup> May 2009, the fourth SCC meeting was held. This meeting aimed to collect all comments and recommendations for all line ministries to update the Sub Decree on the Designated Official Statistics. At the same time, the Sida project presented the experiences and development of the official statistics in Sweden.

At the fifth SCC meeting on 17<sup>th</sup> November 2009, the Sub-Decree of the Designated Official Statistics was finalized. The Chief Advisor of Sida project was invited to present some necessary activities which related to the preparation of the Sub Decree to be effective. In between the fourth and the fifth meetings, the NIS had achieved two important Sub Decrees namely Sub-Decree on the Establishment of New Departments of the National Institute of Statistics, Ministry of planning; and Sub Decree on 2011 Establishment Census of the Kingdom of Cambodia; and had one big event of the release of the final census results of the General Population Census of Cambodia 2008.

At the sixth SCC meeting on 7<sup>th</sup> September 2010, it was reported the activities of NIS in preparing the Sub Decree of the Designated Official Statistics, tasks to be carried out by line ministries and government institutions after the Sub Decree on the Designated Official Statistics was approved. The ASEAN works were also discussed in the meeting which related to the exchange of statistical information in all sectors with reliability, on time and comparability in the ASEAN statistical system. The meeting agreed to strengthen the framework of ASEAN Community Statistical System by 2015.

The seventh SCC meeting was held on 17<sup>th</sup> November 2010. It presented the necessity of coordination and methodology operated in the statistical system. The meeting also

reminded members of committee to submit the completed questionnaire of the survey on Inventory of Official Statistics to NIS. At that time, the questionnaire of Metadata Designated Official Statistics was presented and also explained with instruction how to fill in.

### 3.5 Coordination tasks for NIS according to the legislation

The Statistics Law has given tasks to the NIS to be responsible for the coordination in development activities, including training, with the ministries and institutions of the Royal Government, and the private sectors, at the national and sub-national level.

This annual report and a Directory of Designated Official Statistics are tasks that NIS needs to finalize within a year after the approval of the Sub Decree on Designated Official Statistics.

According to the Sub Decree on the Organization and Functioning of the National Statistical System, Article 5, the NIS is the official national statistical institution of the Royal Government and shall have the responsibility for ensuring coordination of the operations of designated statistical units in the collection, processing, compilation, analysis, publication, dissemination of official statistics and information in relation to statistical matters, with regard to:

- avoidance of duplication in the collection of information for official statistical purposes by designated statistical units;
- attainment of compatibility and integration between official statistics compiled by designated statistical units;
- effective development, documentation and dissemination of statistical concepts, sources, and methods;
- implementation of statistical policies, including policies relating to the dissemination of official statistics and the publication of release calendars in advance of the dissemination of official statistics; and
- maximize utilization and means of collection and dissemination of available information of designated statistical units.

The NIS collaborates with designated statistical units within ministries and government institutions, as well as with the governors of provinces, districts, khans, commune, sangkat in the collection, compilation, analysis, publication, and dissemination of statistics, including statistics obtained from administrative records for the purpose of coordinating statistical activities and ensuring the implementation of statistical standards.

According to the Sub Decree on the Establishment of New Departments of the National Institute of Statistics, Ministry of Planning, the Department of Statistical Standards and Statistical Analysis has been established and given the responsibility to coordinate the implementation of statistical standard and classifications, statistical definitions and statistical methodologies for the carrying out by designated statistical units.

In addition, this Department also created the Bureau of Statistical Coordination that has the following tasks:

- Coordinate the implementation of statistical standard classifications, statistical methodologies and statistical definitions, with the statistical units within ministries and institutions of the Royal Government.
- Establish a directory of existing statistical data of administration, censuses and surveys conducted by the National Institute of Statistics, ministries and institutions of the Royal Government.
- Register all new statistical data of administration, censuses and surveys which have been planned by the National Institute of Statistics, ministries and institutions of the Royal Government.
- Provide statistical consultancy for the data collection of administration, censuses and surveys conducted by ministries and institutions of the Royal Government.
- Coordinate in collecting the official statistical data and necessary data from concerned ministries and institutions of the Royal Government.
- Coordinate statistical matters with ministries and institutions of the Royal Government.

The tasks for NIS are in many ways similar to other designated statistical units, whereas some tasks are because of NIS coordination responsibility. The coordination tasks for NIS are:

- Making official statistical policies
- Prepare legislation regarding statistics
- Prepare the strategic and master plan for statistics
- Work for public awareness of the importance of statistics
- Provide liaison with other countries and international organizations
- Chair the SCC
- Lead the coordination in supporting the content, collection, compilation, analysis and dissemination
- Lead the cooperation
- Facilitating and leading the development of an effective and efficient NSS
- Prepare an annual report on statistical activities of the NSS
- Keep a register of businesses and population frame
- Keep a directory of administrative and statistical data sources
- Maximize utilization of available information from designated statistical units

- Cooperate with and provide advice and assistance to designated statistical units
- Elaborate templates needed
- Lead the development of statistical standards and concepts
- Lead the development of statistical methods
- Lead the training of statistical officers

## 3.6 Tasks for Designated Statistical Units

According to the Sub Decree on the Organization and Functioning of the National Statistical System, Article 6, the designated statistical unit, being the centralized statistical unit within each ministry or government institution, shall have the responsibility for the following tasks:

- Collect, process, compile, analyze, publish, and disseminate official statistics and information in relation to statistical matters.
- Submit the statistics produced and provide related methodological documentation to the National Institute of Statistics in both electronic and paper form.
- Cooperate with the National Institute of Statistics in the collection, processing, compilation, analysis, publication, and dissemination of official statistics and other information in relation to statistical matters, with regard to:
  - avoidance of duplication in statistical activities and official statistics;
  - minimization of respondent burden;
  - attainment of compatibility and the integration between official statistics; and
  - compliance with all statistical policies and standards that are promulgated by the National Institute of Statistics.

The main tasks of the statistical unit are:

- To investigate the user needs
- To check with the directory of data sources at NIS for using already existing data and for avoiding duplication
- To report the new survey to NIS before commencement
- To collect, process, compile and analyze data
- To report to the release calendar at NIS website
- To disseminate results and send the statistics to NIS with necessary documentation
- To get feedback from the users

## 4 Demands on Designated Official Statistics

According to the Statistics Law, Article 4 - Statistical activities shall be guided by the following objectives:

- Supporting the statistical data requirements of Royal Government policymakers in formulating and evaluating economic and social policies and
  programs, in addressing the socio-economic development and welfare of the
  nation, as well as the requirements of decision-makers and researchers in the
  wider Cambodian and international communities.
- Facilitating the development of an effective and efficient National Statistical System
- Enhancing public awareness of the importance of the role and function of statistics in national development programs.
- Encouraging the development of methodology and technology in statistical activities.

The Sub-Decree on designated official statistics also describes the objectives "to serve the statistical information requirements of policy-makers in formulating and evaluating economic and social policies and programs of the country, as well as the information needs of decision-makers and researchers in the wider national and international community's". With that aim the statistical producers within the NSS need to be useroriented in all its activities to reach quality required by policy-makers, decision-makers and researchers. The user needs for the overall system are reflected in the Statistical Master Plan which was prepared by NIS and discussed by key stake holders before adoption by the Statistics Advisory Council in 2007. The guiding star in all statistical development in Cambodia should, therefore, be to produce statistics according to the Statistical Master Plan and other indicators needed, e.g. for the new National Strategic Development Plan 2010-2015. The implementation of the Statistical Master Plan 2008-2015 is important to coordinate since resources are scarce and the development of statistics will be demanding for Cambodia. The current ASEAN work in the ASEAN statistical system will also be of great importance for the development of the statistics in Cambodia. The framework of ASEAN Community Statistical System by 2015 will onwards require coordination within the National Statistical System.

Quality criteria of the statistics are to be taken into account and the coordination mechanism used as a tool to gain higher quality. Coordination of the statistics gives more comparable statistics and enables the users to make analysis with different sources of data. In Article 3 in the Statistics Law the "Statistical Development is based on the principles of accuracy, independence, objectivity, reliability, relevance and timeliness." These principles should always be kept in mind in the production of statistics.

The first principle of *accuracy* means that the statistical result should correctly describe the phenomena it was designed to measure. That is, the statistical result is showing the closest to a true value as possible. The second principle of *independence* means that the statistics should be produced independently and should provide impartial public information to a democratic society. The third principle of *objectivity* means that the

statistics produced should be decided according to scientific principles and professional ethics, on the methods and procedures for the statistical production. The fourth principle of *reliability* means that the statistical result is measured consistently. It is closely connected to accuracy, but reliability does not imply accuracy. Without accuracy there is very little benefit in having reliability. The fifth principle of *relevance* means that the statistics produced meet the real needs of the users. Therefore the contacts with the users are crucial to find out if the statistics produced will shed some light for the user. The sixth principle of *timeliness* means that the statistics should be disseminated as timely as possible. It is calculated as the time between the reference period (point) and the dissemination point.

Other aspects to consider are *comparability* and *availability* where *comparability* is closely related to the relevance. A user of statistics prefers *comparable data* over time and/or between surveys. To be able to compare surveys, metadata with information on concepts, variables and classifications used should be presented. Comparability will increase if the statistics are coordinated. Then it will be possible to use statistics from different sources when analysing a certain problem. In a system of coordinated statistics there are no duplications of the statistics according to variables, populations and reference periods. The statistics produced are also using common classification systems, common methods and common units, populations, variables and/or reference periods.

The *availability* of statistics is mentioned in the Statistics Law Article 19 where it is stated that the statistical data produced should be published and disseminated to all users. Easy accessible data and metadata e.g. on a website will improve the quality for the users.

Some specific examples on coordination of quality are when

- the variable "Household" is defined in the same way in two different administrative registers to be used together
- the level of accuracy is on the same level in three sample surveys to be used for comparison of education level
- an officer in Ministry of Economy and Finance can easily find, on the website of NIS, information on when different economic statistics will be published
- the description of different surveys have the same structure which make it easier for the user to find e.g. definitions of variables for the surveys of interest
- the users can find all statistics published on the NIS website

# 5 Activities within the NSS for coordination and cooperation in 2010

In 2010 NIS prepared the Sub Decree on Designated Official Statistics approved in July 2010 by the Council of Ministers meeting chaired by the Prime Minister Hun Sen. Since then NIS has carried out some of the most urgent activities to comply with the legislation, e.g. a competence inventory of staff in other line ministries within the National Statistical System (NSS) and a smaller meta data collection. The inventory is used to monitor the current situation of NSS staff skills and its need for assistance by NIS. The metadata will be stored in a database and a directory of Designated Official Statistics will be finished in 2011. Some information from these data collections are presented below in chapter 6.

NIS also had a short term consultant from Sweden to assist in prioritizing what were the most urgent activities that needed to be carried out in 2010.

## 5.1 Sub Decree on Designated Official Statistics

In Article 13 of the Statistics Law it is stated that the National Institute of Statistics (NIS), Ministry of Planning, shall be responsible for making official statistical policies in establishing an integrated National Statistical System (NSS), encompassing all designated official statistics and statistical organizational units within ministries and institutions. The Royal Government shall issue a Sub-Decree on the operation of the National Statistical System and designated official statistics.

In accordance with the Statistics Law, the NIS, Ministry of Planning prepared a draft of Sub Decree of Designated Official Statistics.

The Sub Decree on Designated Official Statistics was drafted initially in August 2003 by an IMF Advisor of the NIS. Then, it was revised in September 2005 by Director General of the NIS after the Statistics Law was enacted in May 2005.

This Sub Decree was given advices and good point of view by advisor from IMF, advisors from the Sida project in the NIS of Ministry of Planning and particularly, the good opinions from the two meetings of the Statistics Coordination Committee (SCC) while all ministries concerned as its members had made improvements. At the same time, this preparation also followed the actual condition of the current national statistical system.

The meaning of this Sub Decree was carried out accordance with the Statistics Law which enacted on 9<sup>th</sup> May 2005 and the Sub Decree on the Organization and Functioning of the National Statistical System promulgated on 26 January 2007.

The draft of this Sub Decree was also discussed and reviewed for better improvement by the Council of Lawyers, the Committee of Khmer Linguistics and the Economic Social and Cultural Council (ECOSOCC) in the first meeting on 21 May 2010.

Afterwards, this drafted Sub Decree was passed through inter-ministerial meeting on 8<sup>th</sup> June 2010 in order to review and make final decision of the tasks of each Ministry and Government institution for its implementation after this Sub decree come into force.

The draft of Sub Decree was gone through the last meeting under the presidency of Deputy Prime Minister, Minister in Charge of the Office of the Council of Ministers in order to verify before submitting to the Council of Ministers meeting for approval.

Finally, the Sub Decree on Designated Official statistics was approved in the plenary meeting of the Council of Ministers on 25 June 2010 and it was signed by Prime Minister on 19<sup>th</sup> July 2010.

## 5.2 Competence Inventory

In 2010 NIS collected information on the skills of the staff within the National Statistical System. The purpose of the survey on inventory of official statistics was to monitor the number of staff in the NSS and their skills to fulfil the tasks as producers of Designated Official Statistics. A suggestion to the SCC on the coordination of different training activities was the outcome of the inventory.

A draft survey was discussed internally and then a final draft was presented at the Statistics Coordination Committee (SCC) meeting held on 7 September 2010. The final draft survey was discussed and approved after some minor adjustments. Two weeks after the SCC meeting the survey was sent out to the line ministries responsible for Designated Official Statistics.

At a SCC meeting held on 17 November 2010 NIS presented some initial results from the survey on the line ministries who already had sent the information. Those who had not responded were requested to send in the survey as soon as possible.

When NIS started the data collection on Metadata in January 2011, NIS sent out a final reminder on the survey for Competence Inventory. No more responses came in to NIS. Totally 17 Line ministries responded.

#### 5.3 Meta Data collection

To prepare for a Directory of the NSS, NIS prepared for a collection of some Meta data from the designated statistical units. A draft questionnaire was discussed at the SCC meeting held on 17<sup>th</sup> November 2010 and two weeks later the questionnaire was sent out to the designated statistical units. The work will continue in 2011 to present the Meta data in a Directory and to discuss with members of SCC and SAC how to coordinate the work to use the capacity and resources for statistics effectively.

#### 5.4 Workshop for SCC members

In November 2010 NIS held a workshop for the SCC members on production of designated official statistics with more than 50 participants. H.E. DG San Sy Than presented the National Statistical System of Cambodia and a Sida short term consultant presented reasons for coordination and what to know as a producer of designated official statistics.

## 6 National Statistical System 2010

#### 6.1 Resources within NSS in 2010

According to legislation all line ministries responsible for Designated Official Statistics need to set up a unit for producing this statistics. The line ministries are also required to send information to NIS on the costs for data collection. However, because the budget is not decentralised it has been difficult to calculate the total cost. Some line ministries have only estimated the staff salary, whereas others also have been able to include all the costs. The ICT equipment and donor assistance for data collection should have been included.

Under each line ministry there is information on the number of staff and total budget for the designated statistical unit if it has been available. Before next year edition of the Annual Report the members of the SCC need to discuss how to collect this information in a more standardized manner.

The total number of staff working with designated official statistics at NIS is 314 and other designated statistical units at line ministries and National Bank of Cambodia is 290.

## 6.2 The competence level within NSS November 2010

The results of the 2010 survey on the competence level at the designated statistical units show that about half of the staff at the units responsible for designated official statistics has an academic degree, 29 percent have a Bachelor degree, 21 percent a Master degree and one percent of the staff has a PhD. Only one third of the staff seems to have enough skills (rather high or very high statistical skills) to carry out the tasks in a statistical unit. The number of staff with higher statistical skills is not enough for producing statistics within the National Statistical System and statistical training is therefore required. Statistical production of today is dependent on different ICT tools and the results from the survey presented in the survey indicate that there is a need for ICT training. The capacity of writing and speaking English is on an average level for most staff within the NSS and training is therefore required also in that area.

Basic statistical training is needed for a major part of the staff in the Designated Statistical units. The level is very low and not sufficient to produce statistics in the line ministries. Some staff has enough skills to participate in a course in intermediate statistics or making analysis. The staff with rather high statistical skills will also need more training, in particular in making analysis.

English is essential and recommended. Since English is a skill required for many different tasks at the line ministry and many need this training, each Ministry shall be responsible for its training own staff.

On the job training along with a training course is recommended to deepen the knowledge and make use of the training. Each line ministry is responsible to arrange for the on-the-job training.

## 6.3 Publishing within the NSS

According to the Sub Decree on Designated Official Statistics not all data has been collected or published. In section 6.4 NIS and other statistics units are presented according to the surveys they are responsible for in the Sub Decree. Some data is collected but has not yet been published. Other data is only presented for the Ministry itself and can, if known, be requested by other users. To be considered designated official statistics, however, the statistics need to be published to <u>all</u> users. This is something that needs to be improved by next year.

Where there is a name of a report and no date when it has been published in the presentation below, the report has not been published officially.

## 6.4 NIS and Designated Statistical Units

### 6.4.1 National Institute of Statistics (NIS)

Apart from the coordinating tasks mentioned previously in section 3.5, NIS is responsible for guidance and managing Socio-Economic development planning and statistics in the Kingdom of Cambodia. The main task for NIS is, however, to collect statistical data. All data released by NIS are designated official statistics.

Number of staff: 314

Budget for the NIS: 5,208,000 USD

The designated official statistics of NIS:

#### 1. Census Statistics

- Population census statistics, every 10 year
- Agricultural census statistics, every 10 year
- Establishment census statistics, every 10 year.

- Retail and wholesale trade statistics and indices, quarterly and annual
- Consumer price indices, monthly, quarterly and annual
- Export and import price indices, monthly and quarterly
- Sector satellite accounts
- Labour and wage cost indices
- Producer and services price indices.

#### 4. Environment and Natural Resources Statistics

- Environment and natural resources statistics
- Environment and natural resources satellite accounts.

## 5. Socio-Demographic Statistics

- Demographic and population statistics, annual
- Household income and expenditure statistics, annual
- Other social statistics, annual.

#### 6. Statistical Yearbook

- Statistical yearbooks by national, capital, provincial levels, annual
- Statistical handbooks by municipal, district, khan, commune, sangkat levels annual
- Economic and environment indicators, annual
- Socio-demographic indicators, annual.
